Section Officer (Acad II)

I. To follow and observe the University Act, Statutes, Ordinance, Regulations, Rules and Instructions framed, amended adopted and issued from time to time relating to:-

10. Admission of only eligible students allotted through Coordinator will be made.
 11. To follow curricular course of study as prescribed by the University from time to time including scheme of examinations and conduct of examinations.
 12. Appointment of qualified Teaching/Technical support staff / supporting staff within stipulated period as per the NCTE norms.
- II. Staff Appointment of permanent and qualified Principal and teaching staff on full time basis selected by duly constituted committees as per norms of the NCTE, UGC and the University and appointment will be got approved from the University.
- (ii) Building Construction of sufficient building and infrastructure, play ground and hostel building etc. as per the provisions of the NCTE norms.
- III. Library:- As per the norms of NCTE year wise development of college Library and provision of funds for journals and magazine be made. Year wise bifurcation of books purchased details be submitted.
- IV. Endowment Fund:- Sufficient endowment fund as prescribed in rules be credited and University will be supplied a copy of FDR etc in the name of Registrar and Management Committee.
- V. Faculty members:- Appointment of faculty members as per the norms of NCTE be made.
- VI. (a) Number of admission will be restricted to the number of seats allotted by University. No admission over and above the number of seats allotted will be made.
- (L) No admissions may be given in the subject(s)/course(s) without obtaining the affiliation in the subject(s)/course(s) concerned.
- Non compliance will entail severe action against the college as per the letter no. 31170-313 dated 23-02-2003 and responsibility for the same will be with the college administration.
- VII. In case of any compliance or failure to observe the conditions of the affiliation, the college will be liable for the penalty and action as per the Notification No. 18349 dated 22-05-2012.
